**Dr. Ira Fox Appointed as Chairman of the Local Organizing Committee and Program Director for the World Institute of Pain's 3rd Annual Miami Interventional Pain Hands-on Workshop**

**MIAMI – (December 2, 2015)** – Ira Fox, MD, DABPM, FIPP, ABIPP, co-founder of Anesthesia Pain Care Consultants, has been appointed as Chairman of the Local Organizing Committee and Program Director for the 3rd Annual Miami Interventional Pain Hands-on Workshop, hosted by the World Institute of Pain's (WIP) United States and Brazil sections. The workshop will take place from December 2 through December 4 at the Miami Anatomical Research Center.

Dr. Fox will be presenting on thoracic and cervical neuroplasty. He will be joined by some of top physicians in the growing field of interventional pain management. Lectures will be given in English, and simultaneous interpretation into Spanish and Portuguese will also be available.

The committee will encourage, initiate and supervise projects that should be dedicated to the education, standardization and evaluation of medical doctors within the framework of WIP activities.

Dr. Fox holds the distinction of being the inaugural executive examiner for the WIP & American Academy of Pain Medicine Ultrasonography (AAPMU) 1st Annual WAAPMU International Congress. He is a Fellow of Interventional Pain Practice and Certified Interventional Pain Sonologist (CIPS).

The 30th FIPP Examination and 3rd CIPS Examination will be offered on Saturday, December 5.
